#### Subject: The Electing and Selecting CCM members for the 2024-2026 term

In accordance with the decision made at the CCM meeting on 30 October 2023, CCM Thailand is holding elections to identify new members and alternates to represent different constituencies for the term of January 2024 to December 2026.

## **BRIEF INFORMATION**

## **Roles and Responsibilities of CCM Thailand**

## A. Background

The Global Fund for AIDS, Tuberculosis and Malaria (GFATM) functions to attract, manage and disburse additional financial resources through a new public-private partnership to support the rapid scale-up of measures to prevent and treat HIV, Tuberculosis, and Malaria. It operates as a financial instrument, and not an implementing entity. The Global Fund model is founded on certain principles, underpinned by a series of ethical values:

Global Fund Principles	<b>Global Fund Ethical Values</b>
Country ownership	Duty of care
Partnership	Accountability
Transparency	Integrity
Performance-based funding	Dignity and Respect

Country Coordinating Mechanism (CCM) is a unique country-level mechanism that brings together representatives of all sectors involved in the response to the diseases, including affected populations, and other public health fora to achieve the vision of a world free from the burden of these diseases. CCM Thailand coordinates the development of the national funding request from the Global Fund on behalf of the country and provides strategic oversight to ensure effective and strategic implementation of the approved grant for the NGOs.

As the main governance body charged with securing Global Fund financing and overseeing the implementation of the grant, the CCM Thailand embodies the same principles and values. Ethical, transparent, and responsible decision-making by CCM Thailand is key for program success in the country.

## B. Mandate of the CCM

- 1. The CCM is a multi-sectoral national platform to coordinate and facilitate Global Fund activities to fight against HIV/AIDS, TB and malaria in Thailand.
- 2. The CCM is comprised of representatives of stakeholder constituencies<sup>1</sup> represented at the national level.
- 3. The mandate of the CCM is to mobilize a national multi-sectoral response to develop and submit proposals to the Global Fund to scale up the fight against HIV/AIDS, TB and malaria, and to oversee and support the implementation of activities that are initiated by the CCM in line with national program priorities and supported by the Global Fund.
- 4. The aim of the CCM is to enhance performance of the Global Fund activities in Thailand in partnership with stakeholder constituencies, to promote efficient program implementation, to avoid duplication by harmonizing Global Fund activities with other programs throughout Thailand, and to strengthen coordination among stakeholder constituencies.

## C. Constituency Representation and Expected Roles

Constituency Representation: Membership of the CCM shall be broadly representative of a variety of stakeholders, each with an active constituency concerned to fight against HIV/AIDS, tuberculosis, or malaria. Each constituency brings a unique and important perspective to the work of the CCM, thus increasing the probability of achieving measurable impact against the diseases. The CCM will ensure representation of a gender perspective in CCM membership.

#### (a) Government representatives.

The role of government organizations is linked to their capacity of being main stakeholders for the national and regional strategies and programs for AIDS, Tuberculosis and Malaria. The CCM through government representation should build on national efforts for the specific diseases and be linked to a broader national coordination effort including gender equity, social protection and poverty reduction strategies. Therefore, government representatives represent the views of and report back to senior leadership of the government.

#### (b) Civil Society representatives.

The role of Civil Society representatives from Non-Governmental Organizations (NGOs), academic institutions, people living with diseases, community organizations, key affected populations and faith-based organizations is to contribute to and enhance the control and eradication of AIDS, TB and Malaria. Their own constituencies shall elect the representatives. Individual CCM Members shall hold regular meetings with their constituents to ensure that representative views and concerns are expressed in the CCM forum.

#### (c) <u>Multilateral and bilateral international partners working in-country representatives</u>.

Multilateral and bilateral partners serve many roles including providing policy and normative guidance, assisting with gap analyses towards a shared commitment to national disease responses, and providing expertise, such as in the field of gender. Multilateral and bilateral partners frequently contribute to funding request and advocacy, strengthening, oversight, and coordinating assistance towards harmonization and alignment.

#### (d) Private Sector representatives.

Private sector representatives bring important perspectives, skills, and expertise to assist the CCM in its mobilization and oversight of grant resources. Representatives may include large for-profit companies with a commitment to fighting one or more of the diseases, organizations representing small and medium-sized enterprises and the informal sector, business associations to fight HIV-AIDS, TB, and malaria, representatives from exposed industries, private hospitals and for-profit clinics, and charitable foundation established by corporations.

<u>Constituency representatives</u> shall not represent themselves or any specific organization, but rather the views and interests of the entire constituency.

#### F. Responsibilities of CCM Members

- 1) To attend and participate in CCM meetings in a timely and responsible manner;
- 2) To share relevant experiences and information at CCM meetings;
- 3) To support and adhere to decisions made by the CCM;
- 4) To regularly report on CCM proceedings to organizations and individuals from the constituency represented by the member;
- 5) To abide by the CCM Code of Conduct and Conflict of Interest Policy

#### **G.** Termination of CCM Members

- 1) CCM membership may be terminated by a simple majority vote of members present at a meeting at which there is a quorum, if a member fails to attend more than three regular CCM meetings consecutively.
- 2) The CCM may take such other steps, as it considers appropriate prior to terminating a CCM member's membership.
- 3) In the event a person's membership of the CCM is terminated, or that person resigns their membership of the CCM, the constituency represented by that member may select/elect a person to serve out the remainder of the term of membership.

## Criteria for a person representing TB Key Affected Populations on Thailand's CCM

- 1. The CCM candidate should be from TB Affected Populations representing:
  - a. TB close contact especially in children under 5 years, or drug-resistant tuberculosis TB close contact
  - b. Elderly people who have co-morbidities (DM un-control) or bedridden patient
  - c. Prisoners, personnel in prisons, Correctional institutions, and Juvenile Observation and Protection.
  - d. Public health personnel especially those who provide TB services.
  - e. Migrant population
  - f. People who live crowded places such as crowded community, welfare centers, military camps, and refugee camps.
  - g. Homeless people
- 2. The candidate is willing to disclose their status within the CCM and among other stakeholders involved in the response to TB
- 3. The candidate should have at least 1 year of experience involved in the response to TB.
- 4. The candidate should commit to allocate time to carry the responsibilities they will have as a member of the CCM and engage as needed in communication to and from their community.
- 5. The candidate should understand Global Fund programming and the CCM role.
- 6. The candidate should have strong communication skills and be able to communicate well both with their peers and people of other backgrounds with whom they would interact in their role as a CCM member.

## Roles and Responsibilities

- 4. To respond to questions or requests for clarification and information from constituents in an efficient and prompt manner
- 5. To actively participate in monitoring funded activities and providing feedback to the CCM
- 6. Approve/vote during CCM decision making forums (based on prior consultation with constituents, ensuring that any decision on behalf of men who have sex with men at the CCM forum is based on community consensus *where possible and realistic*)
- 7. If necessary, refuse to agree on an issue during the CCM decision making forum, as per the results of consultations with constituents.
- 8. Obtain information regarding programme implementation from communities in the field in order to identify any abuses or challenges and bring them to the CCM's attention, and to facilitate and follow up on requests for clarification, case finding or other information from constituents pertaining to the implementation of field activities supported by GFATM grants
- 9. Get support and technical assistance (as needed) to ensure effective participation, including the mobilisation of resources from a technical committee consisting of representatives of groups/organisations/community-based networks affected by TB
- 10. In accordance with the Global Fund Guidelines and Requirements for CCM's management of conflicts of interests, to publicly declare in writing any potential conflict of interest, both personal and institutional, during their tenure
- 11. To facilitate the planning of a selection process in the last quarter of their tenure for a representative of TB Key Affected Populations at the CCM
